6. Committee Introduction

6.1 Terms of Reference (staff)

Staff provided a brief summary of the Committee Terms of Reference (TOR).

7. New Business

7.1 Correspondence to Council – Bee Keeping & Backyard Chicken, Bylaw Amendment Proposals (Bonnie Castle)

Council referred the letter to the AAC and Environmental Advisory Committee. It was unclear if Council wanted the committees to receive the letter for information or a recommendation.

The committee discussed the letter and process. The Chair requested staff to provide a summary of how neighbouring communities have addressed urban agriculture (backyard chickens, bee, etc.) by bylaw. Ministry of Agriculture staff also provided some web links to work done in the North Okanagan Regional District and literature on avian flu. Staff will provide more information at the next meeting in order to further discussion and provide some feedback to Council.

7.2 Local Wildfire Update (*Late item*)

The group discussed recent events. At the April AAC meeting the Shuswap Emergency Program (SEP) attended and presented to the group how Emergency Operations Command, the province, and land owners work together during

emergency events, including – coordinating transport during evacuation events. SEP also advocate the ‘buddy farm’ system. Each farm should have their own emergency plan and resources are available in the event that the owners plan cannot happen.

There are funding opportunities to host workshops on Emergency Management and Planning through the Ministry of Agriculture. Staff will look into organizing another SEP presentation in late 2023 or early 2024.

8. Updates

8.2 Ministry of Agriculture – Projects and Grants (staff)

Staff provided a summary of recent grant opportunities and surveys. In addition to these opportunities, details on the Pitch & Plate program were presented. Pitch & Plate provides producers with the opportunity to ‘pitch’ their product to post-secondary and government institutions for wider distribution. Applications – AAC Role

Provide local farming knowledge to ALC, including:

- Assessment of agricultural potential
- Limitations to agricultural development
- History of agriculture on the property
- Impact of the proposal on farm activity on the property and surrounding area



Ways AACs Can Be Involved

- Advising local government on land use **bylaws and policies**
- Providing local knowledge and assessing potential impact of **applications**
- Contributing to the development and monitoring implementation of **agricultural area plans** (*City's plan last updated in 2004)



Applications – Council/Board Role

- Pass a resolution to either forward or not forward application to the ALC
- Have the ability to refuse proposals inconsistent with local land use bylaws
- Can provide additional input or information in resolution as needed



Applications – ALC Role

- Review and make decisions on applications in accordance with s. 6 mandate:
 - To preserve agricultural land
 - To encourage farming
 - To encourage local governments, first nations, etc. to enable and accommodate farm use
- **Must give priority to protecting and enhancing:**
 - Size, integrity, and continuity of the ALR
 - Use of the ALR for farm use
- Prescribe conditions of approval, if applicable
