In regards to our request for Grant Funds, we will be hosting the Club 55+ Games next year in 2024 and our clubhouse needs a bit of a face lift. We have had some issues with ongoing attempted break-ins which has caused damage to our exterior doors and boarded window area. The RCMP have been called regarding this issue and they would try to do random drive-bys. We would like to put into place some window security bars or guards as well as door security hardware. Our club members have installed some interior shelving for storage to help tidy up the clubhouse. We had a kitchen donated to our club and our members have installed it but we would possibly like to have some electrical work done to upgrade our lighting, inside and out. The exterior ground lights are old and quite dim which inhibits our club from playing earlier and later in the season due to it being too dark. Our exterior store room could use some updated shelving as well. The work that has been done in the clubhouse has been by our club members volunteering their time to do these jobs at no cost to the club. We have hopes of painting the exterior and interior of our club house as well as the metal parking barriers that are in place. The interior square footage of the clubhouse is 1400 sq.ft. which would take approx 4 gallons of paint at \$50.00 a gallon, and 4 gallons of primer at \$30.00 gallon, for the exterior we would possibly need 5 gallons of paint at approx. \$248.00.

Due to the age of the building we would appreciate if the electrical could be checked to be sure it is up to current code and the plumbing checked as well as the roof to be sure we have no underlying issues. If you could help us out in anyway, in kind or otherwise it would be much appreciated.

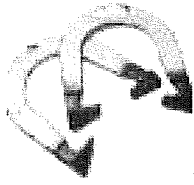
