BYLAW NO. 4726

A bylaw to amend City of Salmon Arm Ticket Information Utilization Bylaw 2760

The Municipal Council of the City of Salmon Arm, in open meeting assembled, enacts that the City of Salmon Arm Ticket Utilization Bylaw No. 2760 be amended as follows:

- 2. That Schedule 1, Section 1 (Building Bylaw No. 4725) be amended to delete "Building Inspector" and "Asst Building Inspector" from the list of "Designated Bylaw Enforcement Officer."
- 3. That Schedule 1, Section 1 (Building Bylaw No. 4725) be amended to add "Building Official" to the list of "Designated Bylaw Enforcement Officer."
- 4. That Schedule 2 be deleted in its entirety that reads:
